DGR – EFFECTIVE RESETTLEMENT OF EX-SERVICEMEN: OUR FIRST AND FINAL GOAL

The Directorate General Resettlement (DGR), Department of Ex-Servicemen Welfare, Ministry of Defence works towards effective resettlement of Ex-Servicemen(ESM) through imparting training and empowering them for a host of employment and self-employment opportunities. It functions as an effective interface between the ESM and the environment and is committed to their successful and gainful resettlement.

EMPLOYMENT OPPORTUNITIES

REGISTRATION

- Registration in DGR by eligible ESM – Officers of the three Services is an online process through the interactive official website of DGR. It is a onetime procedure and is common to all schemes managed by DGR.
- ESM (O) can register before attaining the age of 59 years.
- Requisite supporting documents (details available on DGR website) are also to be uploaded online.
- Provisional registration number of the selected scheme shall be auto generated by the system.
- The Board of Officer is assembled to scrutinize the online application received. After completion of board, scanned copy of final registration is E-mailed to the individual.
- In case the documents are not uploaded within the stipulated time given by DGR (Emp-2) provisional registration shall stand cancelled.
- Details of eligibility criteria for registration as well as for all the schemes offered by DGR are available on the official website of DGR.
- **Change of Scheme (one time only):** Registered officers can submit an application/e-mail to the concerned Directorates in DGR with a copy to Employment–II Dte in case he/she desires to opt for a change of scheme.
- **Registration for JCOs/ORs:** The online registration for JCOs/ORs is now available for Mother Dairy Milk Booth and Safal (Fruit and Vegetable) Booth. Registration for schemes can also be done through personal application through e-mail/post to concerned branch also. Details of Schemes are available on DGR website.

EMPLOYMENT ASSISTANCE FOR OFFICERS/ JCOs/ORs AND EQUIVALENT

All vacancies received in DGR are available on official website which can be perused and selected by the Officers, JCOs and ORs respectively. All JCOs/ORs are requested to register themselves with their respective Rajya Sainik Boards / Zila Sainik Boards of the State of their permanent residence for getting their names sponsored by their respective RSBs/ZSBs for jobs figuring on DGR website. The names can also be forwarded by DIAV/INPA/ DAV.

RESERVATION is provided in Central Civil Services, Central PSUs and Nationalized Banks for ESM to the extent mentioned in relevant Govt. of India Orders on the subject.

SECURITY AGENCY SCHEME

DGR empanelled security agencies are providing quality security services to all CPSEs, Autonomous bodies, Universities, Banks and various Govt. Ministries & Departments as mandated by DPE. MoD has issued comprehensive guidelines for administration of this scheme. The scheme provides resettlement opportunities to retired Officers, JCOs and ORs/equivalent from all three Services. The scheme provides for handsome remuneration, wages and substantial employment opportunities for all.

TRAINING SCHEMES

ELIGIBILITY CRITERIA - OFFICERS

• SERVING OFFICERS :-

- ◆ In the last year of Service, for all superannuating/PMR officers.
- ◆ PMR should have been approved.
- ◆ SSC Officers on-completion of initial contractual service or during extension in last one year.
- ◆ Should not have undergone any other DGR sponsored course, or undertaken/registered for any DGR/DESW scheme.
- ◆ Officers of Indian Army who have taken re-employment with Army are not eligible for the DGR Course during the employment period.

• RETIRED OFFICERS :-

- ◆ Fulfill the criteria of ESM (as per Gol rules).
- ◆ Up to a period of three years post retirement.
- ◆ Should not be re-employed in any Govt/Public/Private Organization, at the time of undergoing DGR Resettlement Training.
- ◆ Should not have undergone any other DGR Sponsored course, or availed any DGR/DESW scheme.

ELIGIBILITY CRITERIA – JCOs/ORsh

• SERVING :-

- ◆ In their last two years of service.
- ◆ Should not have undergone any other DGR sponsored course or registered for any DGR/DESW Scheme.

• RETIRED JCOs/ORs AND EQUIVALENT RANKS :-

- ◆ Fulfill the criteria of ESM (as per Gol rules).
- ◆ Upto five years from the date of retirement/release or max up to the age of 60 years, whichever is earlier.
- ◆ Should not be re-employed in any Govt/Public/Private Organization, at the time of undergoing DGR Resettlement Training.
- ◆ Should not be dismissed from the service.

ELIGIBILITY CRITERIA – WIDOWS.

Widows of deceased officers/JCOs/ORs are to apply for DGR sponsored Resettlement course through their respective ZSB/RSB, directly at DGR.

SELF – EMPLOYMENT OPPORTUNITIES

COAL LOADING AND TRANSPORTATION SCHEME [ESM(O) & ESM]

For ESM(O), the Scheme is administered on the basis of MoU between Coal India Ltd. and DGR. In this Scheme, five Retired ESM (Officers) will form a Company and register as a Pvt. Ltd. Company under Companies Act of 1956 which will carry out work of Coal Loading and Transportation in the designated Coal Subsidiaries. Each ESM Company can have up to 03 Pay loaders and 30 Tipper trucks in which 10 trucks will be reserved for allotment to widows/disabled soldiers, 20 trucks for JCOs/ORs and equivalent. In exceptional circumstances the fleet size may be increased up to 04 Pay loaders and 40 Tipper trucks.

For ESM, the Scheme is administered on the basis of MoU between Coal India Ltd (CIL) and DGR which sets out terms and conditions governing the formation and running of ESM Coal Loading and Transportation Companies in any of the Coal Subsidiaries of CIL. ESM can register directly at DGR/online. Tipper owners are required to provide seed money for Tippers ranging between Rs. 05 to 08 Lakhs depending upon the loan from banks.

COAL TIPPER ATTACHMENT SCHEME FOR WIDOWS AND DISABLED ESM

The Tippers for Widows/Disabled soldiers are purchased by the Company. Widows/Disabled soldiers pay a seed money of Rs. 01 Lakh and they get monthly reimbursement of Rs. 3000/-. At the end of contract after 05 years, One Lakh rupees are returned to the widows/disabled soldiers. Eligibility criteria and other details may be perused from DGR website.

Note:- CIL has withdrawn from MoU since Jan 2020. Fresh registration of companies will commence post revival of scheme.

MANAGEMENT OF COMPANY OWNED COMPANY OPERATED RETAIL OUTLETS

Company Owned Company Operated (COCO) Retail Outlets are made available for Management by Retired Defence officers & JCOs on contractual basis for a maximum period of 03 years. The scheme is operational Pan India. ESM Officers and JCOs should not be above 60 years of age at the time of sponsorship and should be willing to provide bank guarantee as per company's requirement. Officers and JCOs and equivalent are required to be sponsored by the office of DGR. The final selection is done by Board of Officers by the Oil Company and DGR Office has no say in it. The Oil Company pays Rs 30000/- pm as fixed remuneration plus incentive on sale of oil product. The policy guidelines are available on the websites of all major Oil Companies. SOP for sponsorship of names is available on DGR website.

ALLOTMENT OF OIL PRODUCT AGENCY (OPA) DISTRIBUTORSHIP BY OIL MARKETING COMPANIES

Ministry of Petroleum and Natural Gas has a reserved quota of 8% for distributorship of Oil Product Agency i.e. LPG distributorship under Government Personnel category and Retail Outlets (Petrol/Diesel) under 'CC1' category for eligible Armed Forces Personnel. Location for developing Retail Outlets and LPG distributorship are identified by the Oil Company after carrying out requisite feasibility study. Requirements for Retail Outlets and LPG distributorship in the particular locality are advertised through newspapers and the Company's website. After publication of advertisement, applicant can apply directly to the Oil Company. Simultaneously, applicant should apply for DGR eligibility certificate which is required to be submitted to the Oil Company in original at time of selection. The final selection is done through draw of lots by the Oil Company and office of DGR has no say in it. Policy guidelines and eligibility are available on DGR Website.

MANAGEMENT OF CNG STATIONS BY ESM (O) IN NCR

The scheme for management of CNG stations of Indraprastha Gas Ltd. (IGL) is currently run on "Company Owned Company Operated" (COCO) outlets of IGL in National Capital Region (NCR) only. The eligibility Criteria for the ESM (O) for the scheme are available on DGR website. Retired ESM(O) up to the rank of Brigadier & equivalent registered with DGR are sponsored to IGL for every station from the seniority list of CNG and selected on the basis of interview held at IGL. The selected retired Officer is then contracted for management of the CNG station by IGL on a yearly contractual basis for a maximum period of 05 years or till attainment of age of 60 years whichever is earlier. Registration of ESM(O) up to age of 59 years and officer will be sponsored up to the age of 60 years only.

MANAGEMENT OF MNGL STATION AT PUNE AND ADJOINING AREAS

MNGL is subsidiary unit of GAIL (INDIA) & BPCL located at Pune operating CNG Stations similar to IGL at Delhi and NCR. MNGL in consultation with DGR has started operating employing ESM(O) for providing operating services to MNGL owned CNG Stations in Pune and adjoining areas as a DGR Resettlement Scheme. The scheme is similar to that of CNG in Delhi & NCR. The scheme is also being offered to JCOs and equivalent at selected locations.

ALLOTMENT OF MOTHER DAIRY MILK BOOTHS AND FRUITS & VEGETABLE (SAFAL) OUTLETS

Mother Dairy Pvt Ltd. is providing ready built and fully equipped milk booths to ESM. Its fruit and vegetable (SAFAL) shops are offered to ESM of the rank of Naik to JCOs and equivalent. The scheme is available in Delhi and NCR (Gurugram, Faridabad, Ghaziabad and NOIDA), Nagpur and Varanasi. Eligibility criteria for the ESM to be registered under the Scheme, Modalities and other salient aspects are available on DGR website.

EMPLOYMENT SEMINARS

DGR coordinates with CII/FICCI to facilitate the participation of corporates in Employment Seminar/Job Fair organised by DGR all over India in collaboration with the Service HQs. These Employment Seminars/Job Fairs provide walk-in opportunities at no cost to ESM to find a suitable job. Updates of Employment Seminars/Job Fairs will be available on DGR website as and when the Seminars are conducted, same are being also published/advertised on various mass media platforms prior to the event.

PRADHAN MANTRI BHARTIYA JAN AUSHADHI PARIYOJNA (PMBJP) WITH SPECIAL INCENTIVE FOR ESM

The Government of India Scheme, Pradhan Mantri Bhartiya Jan Aushadhi Pariyojna (PMBJP), aims at establishing nation-wide Generic Medicine pharmacies of providing cheaper medicines to all. A special incentive of a one-time grant of Rs. 2 lakhs, in addition to normal incentives (Rs. 5 Lakhs @ 15% of monthly purchase) as applicable, is granted as reimbursement to Ex-Servicemen. Policy guidelines and eligibility are available on DGR Website.
